1. General presentation of the procedure. 1. General description of the submitted materials for the competition.

Dr. Kofinova has provided all documents accepted according to the sample for arranging scientific papers for the competition for Associate Professor at the University Hospital "N. I. Pirogov ". They are supported by the necessary evidentiary material.

2. Candidate's career profile. Dr. Kofinova graduated from Medical University of Sofia in 2014. The same year she started working as a doctor at SBALDB "Prof. Dr. Ivan Mitev", Clinic of Pediatric Gastroenterology, Department of Pediatrics, Sofia. Since May 2023 and until now she has been appointed as a Pediatrician and Pediatric Gastroenterologist in the Department of Pediatric Abdominal Surgery of University Hospital "N. I. Pirogov", Sofia.

Since 2016, Dr. Kofinova has been successively elected as an assistant and chief assistant at the Department of Pediatrics at the Medical University, Sofia. She has participated in many qualification forums in Bulgaria and abroad.

Dr. Kofinova has acquired specialties in pediatrics and pediatric gastroenterology. She defended her dissertation for the award of the PhD on the topic: "Assessment of fibrosis in chronic liver diseases in childhood".

She is a member of the Bulgarian Society of Ultrasound, Bulgarian Association of Ultrasound in Medicine, Bulgarian Society of Ultrasound in Medicine, and ESPGHAN.

She speaks German, English and Russian.

Dr. Kofinova actively participates in the treatment of children with general pediatric and gastroenterological diseases. As a senior assistant, she participates in the training of students of medicine and dentistry at MU-Sofia. She participates in our and international scientific forums, prepares publications for Bulgarian and international journals.

Dr. Kofinova 's scientific interests are in the field of pediatric gastroenterology, pediatric endoscopy and ultrasound diagnostics.

3. Evaluation of the candidate's scientific works and overall academic development.

- General characteristics of scientific production and publication activity. Dr. Kofinova participated in the competition with 28 publications:
 - dissertation
 - participation in collective monographs 6 pcs.
 - participation in textbooks -3 pcs.
 - publications and reports published in scientific journals, referenced and indexed in world-renowned databases of scientific information (only Scopus and Web of Science – 25 issues)

Dr. Kofinova has participated in many scientific activities in international forums, national and regional scientific and practical forums.

• Scientific activity – dissemination and application of the candidate's scientific and practical achievements. Dr. Kofinova publishes in foreign and domestic specialized scientific journals. Most of her works are collective, with the participation of prominent domestic and foreign co-authors, which speaks of the authors and the recognition she has in her circles.

Thus, Dr. Kofinova makes her scientific research and its results available to our and foreign scientific communities. And the interest in them is highlighted, as evidenced by IF. *Evaluation of scientific production and scientific contributions*. The contributions in the publications presented of Dr. Kofinova - independent and co-authored - are significant:

- liver elastography in children
- complications of children with inflammatory bowel diseases.
- role of genetic factors in children with nonalcoholic fatty liver disease.
- behavior and therapy in children with hepatitis B and hepatitis C.
- behavior and therapy in Wilson 's disease.
- surrogate markers of liver fibrosis .
- publications with descriptions of rare gastroenterological pathology in childhood Wilson 's disease , Budd Chiari Sy , 1 p 36 Deletion Syndrome , etc.

Many of Dr. Kofinova's presented publications have scientific and practical contributions and those of a confirmatory nature.

- In the presented self-assessment table for the mandatory minimum scientometric indicators of the University Hospital Medical School "N. I. Pirogov" for the field of medicine (medical-clinical disciplines), Dr. Kofinova has 273.54 points, with a required minimum for AD "Associate Professor" of 200 points.
- Participation in the implementation and management of projects. Dr. Kofinova participated in an educational intra-university project on the topic "Biochemical, genetic and echographic criteria for assessing the degree of development of steatosis and fibrosis in chronic liver diseases in childhood ".

Dr. Kofinova regularly participates in the training (practical exercises and seminar classes) of medical and dental students throughout her academic development. She is a co-author of chapters of study guides that can be used by medical students and postgraduates.
